Dear User, you are informed that the processing of the personal data you have provided is governed by the EU Regulation 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data (hereinafter General Data Protection Regulation (GDPR)).

The data processing is based on the following terms, which you are informed below, that you consent to by checking the corresponding acceptance boxes:

1. Identification

2. Type of data

This website stores on the one hand the cookies that are governed by a specific document, and the personal data provided by you when filling in different forms on this website.

3. Purpose

The processing of your personal data can be for different purposes according to the place on the website where they have been stored and filled in:

A. Contact

If you provide personal data through contact, the treatment will be for the purpose of answering your query or concern.

4. Data retention

The data will be retained for the duration of the relationship between both parties. Once the relationship ends, the data will only be kept if there is a legal obligation to do so.

5. Legal Basis

The legal basis for data processing is the consent you provide by accepting the terms of this website. This consent is granted when you check the specific consent boxes in any of the data collection forms on this site. You have the right to withdraw your consent at any time by contacting us.

6. Data Disclosure

The processed data will not be shared with third parties unless there is a legal obligation to do so. If this policy changes, you will be notified through this same channel.

7. International Data Transfers

The data controller does not intend to transfer personal data to a third country. Therefore, no international data transfer will take place.

8. Exercise of Rights

You have the right to request access to your personal data held by the data controller, as well as to request its correction or deletion, restrict its processing, and request data portability. These requests must be made in writing, accompanied by a copy of your ID, and sent to the address: Calle Amapola 16, Las Candas, 38312 La Orotava. Alternatively, you may contact the data controller to receive a form for your request. If you are not satisfied with the response to your request, you have the right to file a complaint with the Spanish Data Protection Agency (AEPD).

9. Right to lodge a complaint

You have the right to lodge a complaint with a supervisory authority for non-compliance with applicable data protection regulations.
